This Privacy Policy explains how we use the information we collect about you, how you can instruct us if you prefer us to limit the use of that information and what procedures we have in place to ensure the security and privacy of that information.

We are committed to complying with the Data Protection Act 1998 and the EU General Data Protection Regulation (GDPR). These are referred to in this Privacy Policy as the “Data Protection Laws”. The Data Protection Laws give you various rights concerning the way in which we store and use your information.

What information do we collect about you? We gather and use certain information about you to provide our services and perform certain functions in respect of providing general property advice.
